CANCELLATION/REFUND POLICY

1. THE GYM PARK CORP. reserves the right, prior to the birthday party, to cancel the party due to inclement weather. If the party is cancelled, the party will be rescheduled to the next available date.
2. There is a non-refundable, non-transferable down payment fee due at booking. Additional children beyond twelve must be paid in cash on the day of the party.
3. Requests for party fee refunds (not including the non-refundable down payment fee) must be submitted one month prior to the party date. All requests must be submitted in writing. (Please allow 1-2 weeks for processing.)
4. Final payments must be made 2-weeks prior to the party date. Late payments or bookings will incur a \$25.00 fee.

BOUNCED CHECK POLICY

1. In the event that you issue a check to THE GYM PARK CORP. which is dishonored or refused for any reason, you will be charged a \$25.00 service fee in addition to any fee assessed by our bank.
2. All payments after such an occurrence must be made by certified bank check, money order or cash.

THE GYM PARK BIRTHDAY PARTY ETIQUETTE

1. Host and guests should arrive **no earlier** than fifteen (15) minutes prior to the party time.
2. All birthday party participants must be properly attired for birthday party activities. The following is a general guide for proper attire: The proper foot wear for all classes is a pair of gymnastic slippers or socks. Shorts, shirts and leotards are recommended. For safety reasons, **JEWELRY** of any kind is **STRICTLY FORBIDDEN!** No skirts or tutus.
3. For reasons of safety and hygiene, all birthday party participants must observe the following rules while on the Gym Floor: **No Food, No Drinks(of any kind), No Chewing Gum or Candy. No Smoking, Alcoholic Beverages, or Illegal Drugs.**
4. Due to limited space and safety, **NO ONE** will be allowed in the gymnasium except the participants and THE GYM PARK Instructors. Only the Host Parent will be allowed on the gym floor for picture/video taking. There is absolutely no flash photography allowed in the gym. All other parents and guests must remain in the waiting area.
5. All party guests over 3yrs. old should be able to participate without the need for parental supervision. Guests under 3 yrs old must participate with a parent/caregiver. If there are special needs guests, please inform the staff ahead of time so that arrangements can be made.
6. All children two(2) years and younger **MUST** be accompanied by a parent or guardian at all times.
7. To ensure proper supervision and instruction please inform The Gym Park one-week prior to the scheduled party of the number of expected participants at your party.
8. THE GYM PARK will not allow any child to participate in the party without their parents/legal guardian first signing THE GYM PARK BIRTHDAY PARTY ETIQUETTE. (The party permission slip can be downloaded from TheGymPark.com/birthday_party/)
9. During sit down party time (food & cake)please supervise your children.
10. All children of all ages that are on the Gym Floor are considered party guests and will be added to the final bill of participants.
11. If your child is ill or inclement weather occurs before or on the day of the party, we will postpone the party until the first available date and time. A postponement fee of \$75.00 will be charged if you postpone the party.
12. We **do not** provide Food, Drinks, Paper, Dishware, Utensils or Party decorations.
13. All guests must depart from The Gym Park within 10min of the party end time or be charged for an extra ½ hour of party time.
